### **Afternoon Program – Vendor Perspectives on Emerging Demands and Drivers The CIO Workshop as a Change Agent at Bentley**

At the request of the Expert Advisory Panel, Bentley Systems CEO Greg Bentley will discuss the ways in which Bentley has responded to feedback from the CIO Workshop community, as well as to other sources of information on needs and requirements, in the firm's efforts to develop and promulgate new technologies and to elevate practice in the IM service community as a whole.

#### **Collaboration at the Vendor Level to Solve Issues of Interoperability**

A notable development over the last year was the announcement of an agreement by Autodesk and Bentley to expand interoperability between their portfolios of architectural, engineering, and construction (AEC) software. Bentley Executive Vice President Bhupinder Singh, with input from senior Autodesk developers and other software vendors will discuss the hurdles and opportunities that must be dealt with as they work towards new interoperability mechanisms that will benefit of vendors and users alike. Experiences and thoughts for the potential of this sort of collaboration in other contexts will be shared.

#### **Addressing Lifecycle Information Management Challenges – software and implementation**

IBM is a unique organization in that it has a foot in both software delivery and services implementation and, as an Enterprise Systems player, spans projects and operations. Madhavan Vasudevan, a senior executive from IBM who can speak to all these aspects, will discuss where the software and systems integration industry is at in delivering solutions that ease the handover from projects to operations and where the relative strategies are heading.
